Hr-2281 Alan Colosi,2011-08-08 Viacom and Google have settled this case, as reported on March 18, 2014, a week before oral arguments scheduled in the 2nd Circuit on March 24, 2014. Thank you. Does anyone really think US Copyright Law asserts that a copyright owner has to send Google/YouTube a DMCA TakeDown Notice so that they can infringe you in seconds and then never pay you a nickel after you finally get your content removed? No. On June 23, 2010, the case known as Viacom International, Inc./Paramount Pictures vs. Google, Inc. /YouTube, Inc. (07-cv-02103, U.S. District Court, Southern District of New York (Manhattan)) was decided by United States District Judge, Louis L. Stanton. This district level federal case which dragged for three (3) years concerned the infringement and exposition of Viacom's copyrighted content on a public display by YouTube, owned and operated by Google. The public display was-and still is-an immediate worldwide distribution. Viacom asked for \$1 billion USD in damages, but Judge Stanton ruled against Viacom and in favor of YouTube. YouTube claimed their business was defined as a service provider under the provision that classifies a service provider inside HR 2281, the law document also known as The Digital Millennium Copyright Act of 1998 (DMCA). According to Google/YouTube, their existence as a combined company was not responsible for any infringement that occurs on their business model which existed, and still does exist, on the Internet. Only if a content owner notified them properly, in accordance with a so-called phrase characterized as a DMCA Takedown Notice, could Google/YouTube then act and remove (or block) the infringed content. The court released over five hundred sixty-three documents of evidence that contained emails, text messages, depositions, white sheets, financial statements, etc. for public consumption. In addition, all arguments, case law, statutes, amici curiae, authorities, and judgments are public record. Viacom provides a majority of these documents

on their litigation homepage with additional essays that attempt to explain the law in their favor. However, Viacom still lost the case. Therefore, in actuality these documents portray themselves as a plea for assistance-to find the truth; to find the facts. This book is the result of reading every document in that case, line-by-line, amid the study of the statutes, case-law, legislative material, non-redacted evidence, and additional facts with the knowledge of computer science, which apparently is lacking with lawyers, judges, and even the US Congress, but certainly not with Google, YouTube and many clones. Available here are all of the briefs submitted to Viacom's counsel that were created by discovery in the order presented, leading to an amicus curiae equivalent that argues 17 USC § 512(k)(1), the 1998 service provider definition inside HR 2281. QUESTION: Are Google and YouTube really service providers under 17 USC § 512(k)(1)(B)? They claim that they are; however, copyrights are a secured exclusive right, a monopolistic right with trademarks and patents demarcated by Congress under Article 1, Section 8, Clause 8 of the US Constitution. In fact, copyrights are not a third place, runner-up, sacrificial lamb for a new form of free speech that creates environments to assert other people's speeches without permission in bad faith. The Bible of Digital Copyright Law will find that Google and YouTube are not service providers under 17 USC § 512(k)(1)(A) and/or 17 USC § 512(k)(1)(B). And if a Bible of Digital Copyright Law proves that is true, then how much has actually been stolen from copyright and trademark owners by pressing buttons? How Ebook Readers Are Killing Consumers' Rights Renwei Chung,2015-01-23 The purchase of an eBook on restrictive eBook reader platforms only grants the customer a revocable license to view it. To ensure that the customer cannot violate her eBook license, content owners implement Digital Rights Management (DRM) technology to control and protect their works. The Digital Millennium Copyright Act of 1998 (DMCA) criminalizes any act that circumvents DRM technology. Platforms owners, like Apple and Amazon, are currently using licensing agreements, DRM technology, and patents to control copyrighted content. Through licensing, platforms are able to restrict a consumers' fair use and first-sale defense rights under copyright law. Through DRM technology, platforms are able to enforce their licenses and add restrictions that have nothing to do with copyright protection, but severely limit copyright owners' and consumers rights. Through patents,

platforms seek the ability to control the resale transactions of eBooks. Through licensing agreements, DRM technology, and patents platforms have gained more power over copyrighted works than ever intended under our copyright laws. This book proposes an amendment for the DMCA to mandate that all eBook reader platforms that implement DRM technology provide a universal format file for the reading and storage of purchases. A universal format for reading and storage of purchased files would be in accordance with the first-sale doctrine and allow for fair-use exemptions. It provides consumers fair use access to their eBook licenses by allowing them to access their purchases through different platforms. It will make the first-sale defense in the digital sphere relevant by allowing all purchases to be platform agnostic. A universal format protects copyright owners' rights by allowing their copyrighted works to be converted onto other platforms. Furthermore, it can assist patents in governing secondary markets by making the eBook technology more interoperable and the secondary market more liquid. It can also be effective at combatting privacy through "watermarking" and authentication programs. A universal format file specifically for the reading and storage of purchases would be a compromise regarding DRM technology, as copyright owners could still implement DRM technology to limit printing and copying of eBooks if so desired.
